3. It is requested that the appropriate commission be rendered to the KACC if a piece of
furniture sells after it leaves the TFMS to a person who first encountered it at the Show.
4. KACC reserves the right to photograph entries to be used for promotion and publicity.5. All accepted entries shall remain in position as placed by the Show Committee for the
entire duration of the show.
6. The TFMS requires the use of standardized exhibit pedestals (See Attachment "A").
7. In the unlikely event that an entry is deemed unsuitable after delivery, the TFMS
reserves the right to disallow it for exhibit.
